Name

- 1 This Organization shall be known as the United Steel,
- 2 Paper and Forestry, Rubber, Manufacturing, Energy,
- 3 Allied Industrial and Service Workers International Union
- 4 (to be known in short as the "United Steelworkers" and by
- 5 the acronym "USW"). This document shall be known as
- 6 the Constitution and By Laws of the International Union
- 7 and it shall also be the Constitution of each Local Union
- and it shall also be the Constitution of each Local Unio
- 8 chartered by the International Union.

ARTICLE II

Objects

- 9 First. To unite in this union all working men and working women eligible for membership.
- 11 Second. To establish through collective bargaining
- 12 adequate wage standards, shorter hours of work and
- 13 improvements in the conditions of employment for
- 14 workers in industry.
- Third. To engage in educational, legislative, political,
- 16 civic, social, welfare, community and other activities; to
- 17 advance and safeguard the economic security and social
- 18 welfare of workers in industry, the International Union, its
- 19 Local Unions and the free labor movements of the United
- 20 States, Canada and the world; to seek to eliminate all forms
- 21 of discrimination; to protect and extend our democratic
- 22 institutions and civil rights and liberties; and to perpetuate

and extend the cherished traditions of democracy and social and economic justice in the United States, Canada and the world community.

Fourth. To function as an autonomous International Union affiliated with other international unions in national and international federations in the United States, Canada and the free world; to unify and solidify the International Union, its Local Unions and the entire labor movement; and to provide financial and other aid and assistance to labor and other organizations in the United States, Canada and other parts of the world.

Fifth. To take all steps and actions consistent with
 the Constitution and policies of the International Union to implement and carry out the objects, rights, activities and
 responsibilities of this organization.

ARTICLE III

Eligibility

Section 1. All workers in the United States,
Canada, insular areas adjacent thereto and the Western
Hemisphere, for whom the union assumes or seeks to
assume the collective bargaining and other responsibilities
set forth in Article II, and all officers, staff representatives
and employees of the International Union, are eligible for
membership.

Section 2. Persons having supervisory power shall be eligible for membership subject to the terms established by the International Executive Board.

1 Section 3. No person shall be eligible for membership, 2 or for nomination or election or appointment to, or to hold any office, or position, or to serve on any Committee in 3 the International Union or a Local Union or to serve as a 4 5 delegate who is a consistent supporter of, or who actively participates in, the activities of any hate based-racist, 6 terrorist, or other organization which advocates violence 7 to affect government policy or to oppose the democratic 8 principles to which the United States and Canada and our 9 Union are dedicated 10

This eligibility requirement shall be in addition to any other eligibility requirement imposed by any other Article or Section of this Constitution

ARTICLE IV

International Officers, International Executive Board, International Tellers and Delegates to the Conventions of the Federation

- Section 1. The International Officers of the International Union shall be the International President, the International Secretary-Treasurer, the International Vice President (Administration), the International Vice
- 18 President (Human Affairs) and the Canadian National
- 19 Director.

- There shall be one International Vice President at Large and one International Vice President.
- There shall be one District Director for each District.
- 23 The persons duly elected to such positions shall perform
- 24 the functions set forth in this Constitution.

Section 2. The term of office of the International Officers, the International Vice President at Large, the International Vice President and District Directors shall be four (4) years, except as otherwise contemplated in Article V, Section 2, of this Constitution.

Section 3. No member shall be eligible for nomination 6 or election as an International Officer, International Vice 7 President at Large, International Vice President or District 8 Director unless the member (a) shall be in continuous 9 10 good standing for a period of five (5) years immediately preceding the election, (b) is a citizen of the United 11 States or Canada or other country in which the United 12 Steelworkers represents members or has legally declared 13 the intention of becoming a citizen, and (c) has worked 14 15 for three (3) years in an enterprise, public or private, or any other place within the jurisdiction of the International 16 Union, or is an International Officer, International Vice 17 President at Large, International Vice President, District 18 Director or a Staff Representative of the International 19 20 Union.

Section 4. No member shall accept nominations for or hold two or more positions set forth in Section 1 above and Section 28 below at the same time.

International President

Section 5. The International President shall attend and preside at all International Conventions and at all sessions of the International Executive Board. The President shall convene regular and special meetings of

the International Executive Board whenever necessary,

- or when requested by a majority of the members of the
- 2 International Executive Board.
- 3 Section 6. The President shall interpret the meaning
- 4 of the Constitution and the President's interpretation shall
- 5 be subject to review by the International Executive Board.
- 6 Between sessions of the International Executive Board the
- 7 President shall have full power to direct the affairs of the
- 8 International Union subject to the approval of the Executive
- 9 Board. The President may in person, or designate an
- 10 International Officer or a Staff Representative, to visit or
- 11 inspect the office of any Local Union or District.
- 12 Section 7. The International President shall have
- 13 the authority to appoint, direct, suspend, or remove such
- 14 organizers, representatives, agents and employees as the
- 15 President may deem necessary. The President shall fix
- 16 their compensation and, where appropriate, shall establish
- 17 job rates, subject to the approval of the International
- 18 Executive Board.
- 19 Section 8. The International President shall appoint, 20 prior to the opening date of the International Convention.
- prior to the opening date of the International Convention, and subject to the approval of the International Convention,
- 22 such committees as are necessary to conduct the affairs of
- 22 Such committees as are necessary to conduct the arians of
- 23 the International Convention. Such committees shall meet
- 24 before the opening date of the International Convention
- 25 and shall proceed to consider all resolutions, appeals,
- 26 reports and constitutional amendments submitted to the
- 27 International Convention.
- Section 9. The International Officers shall make a full joint report of the administration of their offices and of

- the affairs of the International Union to the International
- 2 Convention.
- 3 Section 10. The International President shall perform
- 4 all such other duties as pertain to the President's office.

International Vice Presidents

- 5 Section 11. The International Vice Presidents shall
- 6 assist the International President in the performance of the
- 7 President's duties and shall work under the direction of the
- 8 International President.

International Secretary-Treasurer

- 9 Section 12. The International Secretary-Treasurer
- shall be the chief custodian of all files, records, books,
- 11 documents and effects of the International Office,
- 12 except such records as properly belong to the offices of
- 13 the International President and the International Vice 14 Presidents.
- The Seal of the International Union shall be held in
- 16 trust by the International Secretary-Treasurer. The Seal
- 17 shall be in a form and design approved by the International
- 18 Executive Board.
- The International Secretary-Treasurer shall cause to be recorded the proceedings of all International
- 21 Conventions and shall cause a record to be kept of all
- 22 actions taken by the International Executive Board.
- The International Secretary-Treasurer shall perform
- 24 the functions set forth in Articles V, VI and VII of
- 25 this Constitution and shall assist the President in the

1 IX, XII and XIII.

Section 13. The International Secretary-Treasurer 2 3 shall be the chief financial officer of the International 4 Union, shall receive and collect all monies due to the 5 International Union, and shall be in charge of and preserve all monies and properties of the International Union. 6 The International Secretary-Treasurer shall pay all bills 7 and current expenses unless otherwise ordered by the 8 International President. The International Secretary-9 Treasurer shall furnish to the International Officers 10 and Executive Board quarterly reports of the financial 11 operations of the International Union. 12

Section 14. The International Secretary-Treasurer 13 14 shall make the necessary arrangements for the maintenance 15 of financial books and records, the receipt of all funds due the International Union and shall deposit all such funds 16 in the name of the International Union in depositories 17 approved by the International Executive Board. The 18 19 International Secretary-Treasurer shall invest all such funds as may be deemed by the International Executive 20 Board to be in excess of current need in such securities as 21 the International Executive Board may decide. 22

Section 15. The International Secretary-Treasurer shall give a bond in an amount to be fixed by the International Executive Board to insure the faithful discharge of the International Secretary-Treasurer's duties. Said bond shall be approved by the International Executive Board. In addition, bonds for the other International

29 Officers, Executive Board members and employees of the

30 International Union, to the extent and in such amounts

- deemed necessary by the International Executive Board,
- 2 shall be provided and approved by the International
- 3 Executive Board. The cost of said bonds shall be paid out
- 4 of the funds of the International Union.
- Section 16. The International Secretary-Treasurer shall keep copies of all important correspondence sent out and received by the International Secretary-Treasurer's office.
- 9 The International Secretary-Treasurer shall perform 10 such other duties as pertain to the International Secretary-11 Treasurer's office or may be assigned by the President or 12 the International Executive Board.
- Section 17. The International Secretary-Treasurer 13 14 shall have the authority, subject to the approval of the 15 International President, to employ with compensation such assistants as may be necessary to conduct the affairs 16 of the International Secretary-Treasurer's office. The 17 compensation and, where appropriate, job rates fixed 18 for such assistants shall be subject to the approval of the 19 International Executive Board. 20

Canadian National Director

Section 18. The National Director of Canada shall be the spokesperson for the Union in Canada on national issues and on Union issues applicable to more than one Canadian District. The National Director of Canada shall chair the National Policy Conference which is the Union's forum in Canada to set priorities and policies for legislative

27 and collective bargaining matters in Canada consistent

International Executive Board

Section 19. The International Executive Board shall consist of the International Officers, the International Vice President at Large, the International Vice President and the District Directors.

Section 20. International Executive Board members 5 shall attend all regular and special meetings of the 6 International Executive Board and shall administer the 7 affairs of the International Union in their Districts and 8 perform such duties as may be assigned to them subject 9 to the direction of the International President. The 10 International Executive Board shall meet twice a year 11 and at such other times as provided for herein. It shall 12 13 enforce the Constitution and carry out the instructions of the International Conventions and, between the 14 International Conventions, shall have power to direct the 15 affairs of the International Union. It shall cause the books 16 of the International Secretary-Treasurer to be audited by 17 18 certified public accountants annually and shall transmit a copy of the audit to all Local Unions upon the completion 19 thereof. The funds and property of the International 20 Union shall be managed, invested, expended or otherwise 21 used to implement and carry out the objects, rights, 22 activities and responsibilities of the International Union, 23 and to administer the affairs of the International Union, 24 in accordance with the Constitution and policies of the 25 International Union. 26

Section 21. Each January 1, the annual salary for the International Executive Board Members shall be changed by the same percentage that average annual earnings for 1 USW members for the most recent calendar year changed

2 from the average annual earnings for the year which

3 preceded it.

4 International Executive Board Members,

5 International Officers, representatives and employees of

6 the International Union shall receive, in addition to their

7 salaries, reimbursement for their legitimate expenses, and

8 such fringe benefits as have been or may from time to time

9 be approved by the International Executive Board.

Section 22. Real estate necessary to the affairs of the International Union may be acquired, held, leased, mortgaged and disposed of by the International Executive Board in the names of the International President and the International Secretary-Treasurer and their successors in

15 office as trustees for the International Union.

Section 23. The International Executive Board shall have the power to remove any of the officers or officials enumerated in Section 1 and Section 28 hereof who, (a) after due trial upon written charges of which a copy shall be given to the accused at least fifteen (15) days before trial, is found guilty of dishonesty, malfeasance or maladministration, or (b) has been expelled as a member of

the International Union in accordance with the provisionsof this Constitution.

Section 24. Vacancies among the International Executive Board, shall be filled by the remaining members of the International Executive Board for the balance of the term. The International Executive Board shall have

29 the power to fill vacancies among International Tellers

30 for the unexpired term. Any member designated by the

- International Executive Board to fill a vacancy pursuant
- 2 to this Section must meet the eligibility requirements for
- 3 the office involved.

Section 25 The International Executive Board shall 4 5 have the power to decide all appeals made to it and its decisions shall be effective when rendered, except that 6 it may stay execution of the decision pending an appeal 7 to the International Convention, notice of which shall be 8 filed with the International Secretary-Treasurer within 9 10 thirty (30) days after the International Executive Board's decision is made known to the parties interested. The 11 International Executive Board may delegate or assign all 12 or part of its authority under this Section to a committee 13 of its members 14

15 Section 26. A quorum of the International Executive Board shall be a majority of the members. Questions 16 coming before the International Executive Board shall 17 be decided by a majority vote of its members present 18 19 at a quorum, except as otherwise provided in this Constitution. Any member may demand a roll call vote 20 21 on any question and in such event each member of the International Executive Board shall have one (1) vote and 22 one (1) additional vote for each 1,000 members or majority 23 fraction thereof in good standing in the District which 24 25 such International Executive Board member represents. In the absence of a roll call vote, the International Executive 26 Board members shall be entitled to one (1) vote each. In the 27 event a roll call vote is taken, the International President 28 shall be entitled to a vote equal to the number of votes cast 29 30 by the Board member who has the highest number of votes.

The International Secretary-Treasurer, the International

- Vice President (Administration), the International Vice 2 President (Human Affairs), the Canadian National
- Director, the International Vice President at Large and the 3
- International Vice President shall each have a vote equal 4
- to one half (1/2) of the vote of the International President. 5

Section 27 The International Executive Board shall 6 have the power to effectuate the merger or affiliation of 7 any other labor organization with the United Steelworkers. 8 Where such action is necessary to effectuate the merger 9 10 or affiliation, the International Executive Board may for a period of up to four (4) years waive the application of 11 any provision of this Constitution to the members of the 12 13 newly merged or affiliated labor organization or continue in existence for those members any provision of such other 14 15 labor organization's constitution with such modifications

as are appropriate.

17 Section 28. There shall be five (5) International Tellers elected at each regular Convention which precedes 18 an International election without another Convention 19 intervening. The International Tellers shall be elected 20 according to geographical areas designated by the 21 International Executive Board for a term which shall expire 22 at the next Convention where International Tellers are 23 elected. The method of election shall be established by the 24 International Executive Board. The International Tellers 25 shall perform their duties in connection with elections to 26 27 International offices as provided in this Constitution. No 28 paid staff representative of the International Union shall

The International Tellers may separate into hearing panels in order to expedite the hearing of election contests. To be eligible to serve as an International Teller, a member must meet the requirements of Section 3 of this Article IV.

Section 29. For each day employed, each International Teller shall receive the greater of \$175.00 or lost time, in addition to legitimate expenses.

Delegates to the Conventions of the Federation

Section 30. The members of the International 12 Executive Board shall be the delegates of the International 13 Union to the conventions of the National Federation 14 15 with which the International Union is affiliated 16 (hereinafter referred to as the "Federation"). Delegates 17 to the conventions of the Federation shall represent the International Union. They shall render a report to the 18 regular International Convention immediately following 19 the convention of the Federation which they last attended. 20 21 The delegates to the conventions of the Federation shall cast their vote as a unit, on all questions coming before 22 the convention in accordance with the instructions of the 23 International Convention or the International Executive 24 Board. In the absence of such instructions, the decision of 25 a majority of the delegates shall determine. 26

ARTICLE V

Nominations and Elections of International Executive **Board Members**

President (Human Affairs) shall be elected by referendum vote of the members of the International Union. 5

6 The International Vice President at Large and the International Vice President shall be elected by referendum 7 vote of the members of the International Union. 8

The National Director of Canada shall be elected for 9 the same term in the same manner and at the same time 10 11 as the other International elections by the members within Canada 12

The members of the International Union within each 13 District shall elect their District Director by referendum 14 15 vote.

Such elections shall be conducted in accordance with 16 the provisions of this Constitution and an International 17 Union Elections Manual to be adopted by the International 18 Executive Board prescribing procedures and rules 19 governing nominations and elections under this Article. 20

The candidates for the respective positions receiving 21 a plurality of the votes cast and meeting the eligibility 22 requirements set forth in Section 3 of Article III and 23 Sections 3 and 4 of Article IV, shall be declared elected. 24

25 Section 2. The next election of the International Executive Board shall be held on Tuesday, November 25, 26 2025, and in every fourth year thereafter on the Tuesday 27

- 1 immediately preceding the U.S. Thanksgiving, and the
- 2 persons elected shall assume their duties beginning March
- 1, 2026 and shall serve until their successors are electedand qualified at which time all money, official records and
- 5 documents and all property belonging to the International
- 6 Union shall be turned over to such successors.
- 7 Section 3. All members in good standing shall be 8 entitled to vote.

Section 4. Each Local Union shall have the right to nominate a member for each office to be filled. During the month of June, 2025 each Local Union shall designate a date, time and place for the holding of a nomination meeting to be held in the month of September, 2025. Each Local Union Recording Secretary shall have the

duty to transmit immediately to the International the

information respecting the date, time and place selectedfor the nomination meeting. The International Secretary-

18 Treasurer shall provide a notice reasonably calculated

19 under the circumstances to inform the members of each

20 Local Union of the nomination meeting in their Local

21 Union.

The International Secretary-Treasurer shall prepare 22 nomination certificates and envelopes and send them to the 23 Local Unions not later than August 15, 2025. The Local 24 Union Recording Secretary shall complete the nomination 25 certificate, filling in the names of the members nominated 26 by the Local Union for the various offices, together with 27 the vote recorded, and shall forward the same to reach the 28 29 International Secretary-Treasurer's office not later than

eight (8) days after the Local Union's nomination meeting.

1 Section 5. The International Tellers shall meet at 2 the Headquarters of the International Union to open and tabulate the nomination returns and shall file a report 3 with the International Secretary-Treasurer setting forth 4 the names of all the members nominated and the total 5 6 number of nominations received. Only those nomination returns which conform to the requirements of this Article 7 and the International Union Elections Manual shall 8 be tabulated by the Tellers, except that timely returns 9 which are deficient only in ministerial respects shall be 10 11 tabulated if the International Tellers are able to ascertain by independent investigation that they are authentic and 12 accurate. The International Secretary-Treasurer shall, not 13 later than October 17, 2025, notify all candidates of the 14 tabulation of nomination returns and ask them to have the 15 16 officers of their Local Union certify to their membership 17 in good standing.

For the International President, the International 18 Secretary-Treasurer, the International Vice President 19 (Administration), the International Vice President (Human 20 21 Affairs), the International Vice President at Large and the International Vice President, the required number 22 of Local Union nominations shall be five (5) plus one for 23 each 10,000 members (or majority fraction thereof) in 24 good standing as of March 31, 2025. The required number 25 of Local Union nominations for the National Director of 26 Canada shall be five (5) plus one for every 10,000 members 27 (or majority fraction thereof) in good standing in Canada 28 29 as of March 31, 2025.

The required number of Local Union nominations for District Director shall be five (5) plus one for every 10,000 members (or majority fraction thereof) in good standing in the District as of March 31, 2025.

Section 6. Any nominees notified in accordance with Section 5 of this Article who desire to continue as candidates must have their certificate of membership in good standing attested by the officers of their Local Union and return said certificate to the International Secretary-Treasurer by October 27, 2025.

All protests in connection with nominations must be filed with the International Executive Board and must be received by the International Secretary-Treasurer not later than October 6, 2025, except for protests filed pursuant to the fourth paragraph of this Section which must be received by the International Secretary-Treasurer by October 20, 2025.

The Board shall have the power to decide all questions involved in such protests, including the question of whether any violation is sufficient to require invalidation of a particular Local Union nomination.

If a protest alleges that a candidate was properly nominated by a particular Local Union but was not credited with that nomination because the return was not received or was not received in timely fashion, and if the International Executive Board determines that a candidate was in fact properly nominated by such Local Union, it shall credit the candidate involved with such nomination. The Board shall invalidate any protested Local Union nomination if it finds that there was a violation which may have affected the outcome of the nomination at that Local Union.

If the International Executive Board invalidates the nomination of one or more Local Unions, and if the International Executive Board determines that the rerun of such Local Union nominations might enable a candidate to have a sufficient number of nominations to appear on

1 the ballot, then the International Executive Board shall direct immediate new nominations to be run under its 2 supervision in any Local Unions whose nominations were 3 invalidated. In such event, the International Executive 4 5 Board is empowered to postpone the election for the office 6 involved where, in its judgment, it is necessary to do so. The Local Union nominations which are not invalidated 7 shall remain in effect. The new date for any postponed 8 election shall be set by the International Executive Board, 9 and the International Secretary-Treasurer shall institute 10

Immediately following the ruling of the International 12 Executive Board on the nomination protests, 13 International Secretary-Treasurer shall notify a11 14 candidates who have received the required number of 15 nominations and ask if they desire to be placed on the 16 17 ballot. In order to be placed on the ballot, candidates must respond in writing within five (5) days of the date of 18 notification. 19

20 The procedure set forth in this Section is the 21 only procedure by which protests in connection with nominations may be processed. Nomination protests are 22 not subject to further review within the Union following 23 the election. A candidate who does not receive sufficient 24 nominations to appear on the ballot, following the 25 disposition of any nomination protests under this Section 26 6, shall have received the final disposition of such efforts 27 to become a candidate. 28

If only one eligible member receives a sufficient number of nominations, no election for that position shall be held and such member shall automatically be declared the person elected for that office. Section 7. No nominee filing an acceptance with the International Secretary-Treasurer shall be allowed to withdraw such acceptance.

If a nominee for International Officer, International 4 5 Vice President at Large, International Vice President, or 6 District Director who has complied with Section 6 above shall die prior to the date of the election, the election for 7 the office involved shall be postponed and nominations 8 for that office reopened. Any other nominees for said 9 office who have complied with Section 6 above shall 10 11 continue to be candidates and hold the nominations from the Local Unions previously received by such nominees. 12 The International Executive Board shall set a new early 13 election date for the office involved and the International 14 Secretary-Treasurer shall institute the machinery to permit 15 16 additional candidates to be nominated for that office in the 17 same manner as in the case of regular elections, subject to the previous sentence. 18

19 Section 8. The International Secretary-Treasurer shall prepare ballots giving the names and places of residence 20 of those accepting nominations, also showing the positions 21 for which the various nominees are candidates, and 22 forward them to the Local Unions in sufficient numbers 23 to supply each member not later than two (2) weeks prior 24 to the date of election. "Tally Sheets," one "Return Sheet," 25 and one envelope for "Return Sheet," must accompany the 26 ballots sent each Local Union. In arranging the ballots, the 27 International Secretary-Treasurer shall place the names of 28 the different candidates on the ballot in graduated order, 29 in accordance with the number of nominations received. 30 31 The ballot shall be prepared on special paper,

employing a special watermark, to protect against

1 duplication of the ballot.

The ballot shall be numbered in the upper left-hand corner, in such a manner that the number can be torn off before the ballot is placed in the ballot box. The ballot shall contain a statement instructing the voter to tear off the number before depositing the ballot in the ballot box, and assuring the voter that when this is done, it will be impossible to determine which ballot the voter has cast.

Notwithstanding any other provision in this Article, the International Executive Board may establish standards for the authorization of the use of (i) voting machines, (ii) mail ballot or (iii) remote electronic voting systems under procedures which provide safeguards for their proper use.

14 Section 9. Every Local Union with members eligible 15 to vote shall be required to conduct an election. In the event that the International Secretary-Treasurer should conclude 16 that any such Local Union may not be planning to conduct 17 an election, the International Secretary-Treasurer shall 18 contact the Local Union to assure that the Local Union is 19 20 planning to hold such election or, failing such assurance, shall make arrangements for the International Union to 21 22 conduct such election at Local Union expense.

Section 10. Each Local Union shall designate, at a 23 24 regular meeting of the Local Union held in June, 2025, the place or places where its November 25, 2025 election shall 25 be held, the hours of the election at each such place, and 26 27 the place where the votes shall be tabulated. The voting place or places so designated shall be the official voting 28 29 place or places of such Local Union. The hours designated 30 shall be such as will permit all members who so desire to vote. 31

1 Each Local Union shall promptly furnish to the 2 International Secretary-Treasurer the information 3 respecting the place or places and hours of its election and 4 the place where votes shall be tabulated when requested 5 to do so by the International Secretary-Treasurer.

At least fifteen (15) days prior to the election, notice
of the date, place and hours of the election and the offices
to be filled shall be mailed by the International SecretaryTreasurer to each member in good standing of the Local
Union to the member's last known home address.

Each candidate for International Office or District Director shall, upon request, following the International Executive Board's disposition of all nomination protests filed pursuant to Article V, Section 6, be entitled to obtain from the International Secretary-Treasurer the information concerning the date, place and hours of the election and the place where the votes are to be tabulated in each Local Union under procedures set forth in the International Union Elections Manual.

Union be tabulated in any place other than the place so designated for such tabulation by the Local Union. No member shall be allowed to interfere with the official Local Union Tellers during the tabulation.

Section 11. No member shall be allowed more than one 25 (1) vote for any candidate for a particular office, nor shall 26 the Local Union Tellers record the vote of any member 27 who is not present at the time the election is held, except 28 that any member whose work will require the member to 29 be more than fifty (50) miles away from the polling place 30 31 and any member who is prevented from appearing at the polls because of service in the armed forces or vacation 32

Section 12. Each Local Union shall establish a 3

4 committee of Local Union Tellers. The committee shall

5 consist of the Local Union President, Financial and

Recording Secretaries, who shall automatically be Local 6

Union Tellers. The Local Union may select additional Local 7

Union members to serve as Tellers on the committee. The 8

Local Union Tellers shall supervise the election, and when 9

10 requested, assist the members in voting, and tabulate the

11 votes cast by the members for the respective offices, and

enter on the "Return Sheet" furnished by the International 12

Secretary-Treasurer for that purpose the total number 13

of votes cast for each candidate. The correctness of the 14

"Return Sheet" must be attested with the Local Union seal 15

16 and signatures of the President and Recording Secretary

Section 13. Should it be proved that more votes are 18 recorded on the "Return Sheet" than were actually cast 19 by the members, the vote of the Local Union shall be 20 invalidated, and those responsible for the fraud shall be 21

punished. 22

Section 14. After the votes have been tabulated and 23 the "Return Sheet" attested, it shall be turned over to the 24 Recording Secretary, whose duty it shall be to see that 25 the "Return Sheet" is properly attested, enclosed in a 26 special envelope furnished by the International Secretary-27 28

Treasurer for that purpose, and forwarded at once by

29 certified mail or some other method demonstrating

transmission to the International Tellers, in care of the 30

- 1 International Headquarters. "Return Sheets" post-marked
- 2 later than ten (10) days after the election shall not be
- 3 tabulated by the International Tellers.
- 4 Section 15. The envelopes for "Return Sheets"
- 5 furnished the Local Unions must have the name of the

- Section 16. When the "Return Sheets" reach the International Tellers, they shall examine the envelopes to see if they are intact, make a proper record of their receipt,
- 13 see if they are intact, make a proper record of their receipt, 14 and deposit them unopened in a securely locked receptacle
- 15 provided for that purpose.
- Section 17. The International Tellers shall retain the services of a public spirited and impartial organization
- 18 experienced in the conduct of elections. The organization
- 19 so retained by the International Tellers shall, under the
- 20 supervision of the International Tellers, tabulate the votes
- 21 cast for the various nominees and file this tabulation with
- 22 the International Tellers.
- 23 Section 18. Except as hereinafter provided in 24 Section 27, all contests in connection with the votes of any

- 1 Local Union must be received by the International Tellers
- 2 within fifteen (15) days of the election. Such contests can
- 3 be filed only by a member of the Local Union whose vote
- 4 is contested for any of the offices for which such Local
- 5 Union was voting, or by any candidate for the office for
- 6 which the member was running, in accordance with the
- 7 International Union Elections Manual to be adopted by the
- 8 International Executive Board.

Section 19. Except as hereinafter provided in 9 10 Section 27, the International Tellers shall decide the legality of the votes of any Local Union. The International 11 Tellers shall not count the votes of any Local Union that 12 is not in good standing. The International Tellers shall 13 not count the votes of any Local Union that has cast more 14 15 votes than the number of members in good standing during the month preceding the one in which the election is held 16 unless and until they determine that there is a satisfactory 17 explanation therefore. The International Tellers shall not 18 count the votes of any Local Union whose "Return Sheet" 19 20 is not attested as required by Section 12 of this Article unless and until they have investigated and verified that the 21 "Return Sheet" is authorized and accurate. 22

Section 20. The votes cast by members of each 23 24 Local Union shall be tabulated, and the results published separately. The entire total vote shall also be tabulated. 25 The complete report shall be prepared and sent out to the 26 Local Unions, to each member or group of members of a 27 Local Union who filed a contest, and to each candidate 28 29 by the International Tellers not later than February 30 11, 2026. In the event the International Tellers refuse,

for any reason to tabulate the vote of any Local Union,

1 their reason must in every instance be shown on their report. Any of those receiving a copy of the report of the 2 International Tellers who disagree with the disposition 3 by the International Tellers of a contest filed pursuant to 4 5 Section 18 of this Article may file comments on the report 6 with the International Executive Board. In addition, a candidate or an affected Local Union may file with the 7 International Executive Board a contest to the report of the 8 International Tellers if the contest arises initially out of the 9 report of the International Tellers (for example, failure of 10 the International Tellers to include in their tabulation the 11 vote of a Local Union). Such a contest must be received 12 within fifteen (15) days following the distribution of the 13 report of the International Tellers.

15 Section 21 The International Executive Board shall 16 consider the report of the International Tellers, the report of the Campaign Conduct Administrative Committee 17 referred to in the last paragraph of Section 27 of this 18 Article, any contest filed pursuant to Section 18 or Section 19 20 20 of this Article and any comments on either of these reports and shall render its decision on the election prior 21 22 to March 1, 2026.

If the International Executive Board invalidates the 23 vote of one or more Local Unions, and if the International 24 Executive Board determines that the outcome of the 25 election for any office may have been affected by the 26 invalidated votes, then the International Executive 27 Board shall direct a rerun of the entire election under its 28 supervision or, in its discretion, shall direct that a new 29 election under its supervision be held in the Local Unions 30 31 whose votes were invalidated and the results of the voting in those Local Unions shall be added to the total valid 32

votes of the candidates.

If a contest protests the failure to count a "Return 2 3 Sheet" because it was postmarked too late, received after the International Tellers have issued their report, or was 4 5 not properly attested, and if the International Executive 6 Board determines that the votes shown on the "Return Sheet" accurately reflect a proper vote of the Local Union, 7 then the International Executive Board shall count the 8 votes of the Local Union. If a contest alleges that a valid 9 election was held in a Local Union which failed to send 10 in its "Return Sheet" and the International Executive 11 Board determines that a Local Union did properly vote but 12 failed to send in its "Return Sheet," then the International 13 Executive Board shall credit each candidate with the 14 number of votes received

No other contests or appeals will be permitted.

17 Section 22. In case of a tie vote for any of the 18 candidates for a particular office, another election shall be 19 held for that office among the candidates involved in the tie.

Section 23. The Local Union Tellers shall seal the 20 21 ballots on completion of their tabulation and shall turn over such sealed ballots and all other records in their possession 22 pertaining to the election to the Recording Secretary at the 23 conclusion of their report to the Local Union. Such sealed 24 ballots and other records pertaining to the election shall 25 be retained by the Recording Secretary for at least one 26 (1) year. The Financial Secretary shall retain the records 27 in the Financial Secretary's possession pertaining to the 28 29 election for at least one (1) year.

Section 24. No member shall be allowed to loiter

- 1 around the voting place or to interfere in any way with the
- 2 elections of any Local Union. If a candidate so desires,
- 3 that candidate shall have the right at the candidate's
- 4 expense to have an observer, who shall be a member of the
- 5 International Union, at the polls and at the counting of the

- 7 Section 25. Local Union Tellers shall be held 8 personally responsible for any irregularities in connection
- 9 with the conduct of the elections in their Local Unions.
- Section 26. It shall be the imperative duty of the Local Union Tellers to make a complete report of the election at the first regular meeting of their Local Union following
- the first regular meeting of their Local Union following the election, and it shall be further the duty of the Local
- 14 Union Recording Secretary to make a complete record of
- 15 same in the minutes of said meeting.

Campaign Conduct Administrative Committee

Section 27. No candidate (including a prospective candidate) for any position set forth in Article IV, Section

18 1, and supporter of a candidate may solicit or accept

19 financial support, or any other direct or indirect support of

20 any kind (except an individual's own volunteered personal

21 time) from any non-member. For purposes of this Section,

22 the term non-member means any person who is either not

23 eligible for membership under Article III or not in good

24 standing or any foundation, corporation or other entity

25 whose funds are derived in whole or in part from any

26 person not eligible for membership under Article III or not

27 in good standing.

1 The International Executive Board shall adopt 2 regulations, for incorporation into the International Union Elections Manual, as necessary to implement this 3 provision and to assure conformity with the obligations 4 prescribed in this Section. Such regulations shall include 5 6 requirements for reporting by candidates and their supporters of information pertinent to administration of 7 and compliance with this Section, with such frequency, 8 not to exceed weekly, as the International Executive Board 9 deems appropriate. 10

A Campaign Conduct Administrative Committee 11 shall administer and enforce this Section This Committee 12 shall consist of three persons who shall be distinguished, 13 14 impartial citizens who are not members of the International Union. The term of the present Committee shall end on 15 16 July 31, 2028. Upon the completion of this term and each 17 subsequent term, the International Executive Board shall appoint successors for a four year term. If a Committee 18 member dies or resigns, the International Executive Board 19 20 shall appoint a replacement. A quorum shall consist of two members of the Committee. The International 21 President shall fix the compensation and expenses of the 22 23 Committee members, and shall arrange for the provision of supplies, services, and all other assistance required by 24 the Committee. The Committee shall have the following 25 26 powers:

27 (a) The Committee shall have the authority to contact 28 any and all non-members who it feels may be providing, or 29 attempting to provide, prohibited support to any candidate, 30 and attempt by persuasion to convince such non-members 31 to refrain from providing such support.

1 (b) The Committee shall have the power (i) to direct 2 any candidate, or any supporter, to cease and desist from any course of conduct which the Committee believes 3 breaches this Section or the regulations of the International 4 5 Executive Board adopted pursuant to this Section, and (ii) 6 to direct any candidate, supporter or non-member to take such corrective action as the Committee deems appropriate 7 to cure the effects of any violation and/or assure that any 8 improper conduct will not have an effect upon the election. 9

(c) The Committee shall receive and promptly review the information candidates and their supporters are required to file by the regulations of the International Executive Board and by such additional requirements as the Committee may establish. The Committee may require candidates and their supporters to report whatever additional information the Committee deems appropriate to perform its functions.

(d) In the event that a candidate, or a supporter 18 of a candidate with that candidate's knowledge or 19 acquiescence, willfully and substantially breaches the 20 obligations prescribed in this Section, or the regulations 21 adopted by the International Executive Board pursuant 22 to this Section, the Committee shall, upon notice and 23 hearing under such expedited conditions as the Committee 24 25 deems appropriate in the circumstances, have the power to declare such candidate disqualified, and to so notify the 26 International Tellers. 27

(e) If the Committee in its sole discretion determines that legal proceedings are necessary for the enforcement of this Section 27, it may institute whatever legal proceedings

- it deems appropriate, in the name of the International
- 2 Union. The Committee shall be the only party authorized
- 3 to institute legal proceedings to enforce the provisions of
- 4 this Section 27.

5 The Committee mav recommend to the 6 International Executive Board that additions amendments be made to the regulations adopted by the 7 International Executive Board pursuant to this Section and 8 shall have such other powers as the International Executive 9 10 Board determines are necessary for the implementation of this Section or, if the International Executive Board deems 11 it advisable, any other Section of Article V. 12

Any member who believes that another member is violating these provisions may file a complaint with the Committee. The Committee shall process that complaint in such manner as it deems appropriate, and may adopt rules with respect to the filing and processing of member complaints.

With respect to any pre-election matters within its jurisdiction, decisions of the Committee shall be final and binding, and not subject to review by any tribunal within the Union.

The Campaign Conduct Administrative Committee shall have exclusive jurisdiction of all post election contests to all or part of the election based upon the following grounds:

- (1) Alleged violations of this Section 27;
- 28 (2) Alleged violations of any rules or regulations 29 adopted pursuant to this Section 27; or
 - (3) Alleged violations of the prohibition (contained

in the International Union Elections Manual adopted
 pursuant to Article V) against the use of union or employer
 funds or facilities for campaign purposes.

A candidate who wishes to file a contest on any of the 4 5 above grounds must, in order to perfect such contest, file 6 the contest with the Campaign Conduct Administrative Committee within such time period and pursuant to such 7 rules as the Committee shall establish. The Committee 8 shall investigate such contests, make determinations on 9 those contests and make a report of its determinations and 10 recommendations to the International Executive Board 11 in time to be considered by the International Executive 12 Board prior to March 1, 2026. 13

ARTICLE VI

Conventions

14 Section 1. The next regular International Convention shall be held on the third Monday of April, 2028, and 15 regular International Conventions shall be held on the 16 same date every three years thereafter at such places 17 as may be determined by the International Executive 18 Board, provided that the date of holding such Convention 19 may be advanced or postponed upon a resolution to that 20 effect adopted by the International Executive Board and 21 approved by a majority of the members of the International 22 Union upon a referendum vote. 23 Where availability of suitable facilities or other 24

related circumstances warrant or require, the date of holding such Convention may be advanced or postponed, without referendum vote of the membership, to another date in March through August of the Convention year, by

Amalgamated Local Unions may elect delegates through the alternative method below:

If election of delegates by Unit is selected, each Unit

of two hundred (200) members or more shall be allowed election of their own delegate and all others shall be 2 combined to allow the maximum number of delegates. 3 It shall be the responsibility of the Local Union to notify 4 the International Secretary-Treasurer of its intent to select 5 6 delegates by the amalgamated option method, stipulating

the designated Units and any and all combining of Units. In no event shall the total number of delegates elected 8 using the alternative method allow more than one and 9 one-half times the delegates allowed under the standard 10 11 method

Section 3. Representation shall be based upon 12 13 the average of the paid and exonerated membership of the Local Union for the first three quarters of the year 14 preceding the year in which the International Convention 15 16 is held. Such membership shall be based upon the records of the International Union. A Local Union which has 17 been chartered for less than three (3) months preceding 18 the month in which the International Convention is held 19 20 shall be entitled to send guests only to the International 21 Convention.

Section 4. Local Unions of less than 500 members 22 may combine with similar Local Unions within a 23 reasonable radius of one another in the same District, 24 and elect delegates to represent them, but no delegates so 25 elected shall be entitled to more than ten (10) votes in the 26 International Convention. 27

Section 5. No Local Union shall be entitled to 28 29 representation at the International Convention unless the Financial Secretary has paid to the International Secretary-30

- Treasurer all dues, initiation fees and assessments collected from the members 2
- Section 6. Any Local Union becoming delinquent 3 must comply with Section 9 of Article XIV and be in 4 5 good standing for four (4) months previous to the month in which the International Convention is held, before it 6 will be entitled to representation. 7

Section 7. No member shall be eligible to be a delegate 8 to an International Convention unless the member (a) is 9 employed in an enterprise, public or private, or any other 10 place within the jurisdiction of the International Union 11 or is one of the staff representatives of the International 12 Union. The International Officers and the members of 13 the International Executive Board shall be ex-officio 14 15 delegates to all International Conventions: (b) shall have been in continuous good standing for a period of twenty-16 four (24) months immediately preceding the International 17 Convention; or if the member's Local Union has been in 18 19 existence for less than twenty-four (24) months prior to the International Convention, the member must have been in 20 continuous good standing from the time that said member 21 joined such Local Union; and (c) has attended at least one-22 third (1/3) of the regular meetings held by the member's 23 Local Union during the twenty-four (24) month period 24 immediately preceding the month in which the delegate 25 election is to be held. Meetings which a member was 26 prevented from attending because of such member's Union 27 activities, working hours, service in the armed forces of 28 the United States or Canada, sickness which confines, 29 30 childbirth (if the meeting occurs within twelve (12) weeks of the date of birth), death in the immediate family, or jury

Special International Conventions

- 7 Conventions shall be upon the same basis as govern
- 8 regular International Conventions.
- 9 Section 18. Local Unions demanding a special
- 10 International Convention must state the reason or reasons
- 11 why such International Convention is desired, and it shall
- 12 be the duty of the International President to state said
- 13 reason or reasons in the Call for the special International

- 15 Section 19. Special International Conventions shall
- 16 not have authority to consider any matter other than that
- 17 which is specifically stated in the Call for the special

Credentials Committee

- 19 Section 20. Prior to the opening date of any regular
- 20 or special International Convention, the International
- 21 Executive Board shall meet and constitute itself, or a
- 22 subcommittee, as the Credentials Committee for the
- 23 International Convention. Appeals from its decisions shall
- 24 be made to the International Convention. The International

- 1 Convention shall not be constituted for business until the
- 2 Credentials Committee shall have examined and reported
- 3 on the credentials of all delegates present at the scheduled
- 4 time of opening.

ARTICLE VII

Local Unions

5 Section 1. One hundred (100) or more persons 6 eligible for membership in the International Union shall constitute a Local Union upon receipt of a charter from the 7 International Secretary-Treasurer under the terms herein 8 provided, except that the International President may 9 authorize the International Secretary-Treasurer to issue 10 11 a charter to a Local Union with less than this number in 12 special circumstances.

The International Executive Board may establish rules and procedures under which all or part of the jurisdiction of one Local Union may be transferred to another Local Union, with appointment of provisional Unit officials and Amalgamated Local Officers where necessary.

Section 2. Upon approval of the charter application 18 by the International Officers, subject to review by the 19 International Executive Board, the International Secretary-20 Treasurer shall issue to the applicants a Local Union charter 21 which shall contain such provisions as the International 22 Union may require; the International Secretary-Treasurer 23 shall also deliver to said applicants one Local Union seal 24 and such other initial supplies as may be necessary to 25

conduct the affairs of the Local Union.

1 Section 3. No Local Union shall be dissolved, except 2 with the approval of the International Executive Board.

Section 4. The Local Unions shall be charged with the duty of enforcing this Constitution as affecting their membership.

The funds and property of the Local Union shall be managed, invested, expended or otherwise used to implement and carry out the objects, rights, activities and responsibilities of the Local Union or the International Union, and to administer the affairs of the Local Union, in accordance with the Constitution and policies of the International Union and the By-Laws of the Local Union.

Section 5. Local Unions may adopt, subject to approval by the International Union, such by-laws and rules as do not conflict with any of the provisions of this Constitution or the policies of the International Union. Local Unions which do not adopt such by-laws shall be deemed to have adopted the standard By-Laws for Local Unions issued by the International Union.

Notwithstanding any provisions of the Constitution to the contrary, the International Executive Board shall issue rules and special by-laws governing Amalgamated Local Unions.

23 provisions 24 Notwithstanding any of Constitution the contrary, the International 25 to Executive Board may establish standards, including 26 the process with respect to obtaining authorization 27 of variances, which provide safeguards for their 28 29 use, for Local Unions whose circumstances warrant an accomodation to address 30

the special needs, circumstances, and conditions of
 members on such matters as Local Union and International
 Union elections, conduct of meetings, formation of

Section 6. Local Unions shall hold a general membership meeting at least once every month, except that a Local Union may, with the approval of the membership and the District Director, hold meetings less often, but in no event less than quarterly.

Section 7. All Local Unions are required to affiliate with the appropriate central and local bodies chartered by the Federation.

14 Section 8 All Local Union Officers and Grievance Committee Members shall be elected for a term of three 15 (3) years at the last meeting in April, 2027 (or during such 16 other hours or day in April designated by the membership) 17 18 by a plurality vote of the members participating in a referendum vote, and shall serve until their successors 19 are elected and qualified, at which time all money, official 20 records and documents, and all property belonging to the 21 Local Union shall be turned over to such successors. The 22 International Executive Board shall establish procedures 23 24 which permit members who are prevented from appearing at the polls because of service in the armed forces or 25 vacation to vote by absentee ballot. 26 An officer who retires from an enterprise serviced by 27

the Local Union shall not be permitted to continue in office.

1 The date of Local Union elections for Local Union 2 Officers and Grievance Committee Members must be advertised among members at least fifteen (15) days 3 previous to the date of the election by mailing notice of 4 5 the date, place and hours of the election to each member in good standing at the member's last known home address. 6 The notice must also specify the Local Union offices to 7 be filled. Nominations shall be made at the immediately 8 preceding meeting. However, where a Local Union holds 9 two meetings in each month, nominations may be made 10 at the last meeting in the month preceding the month 11 in which the election is held. Notice of the nominations 12 meeting shall be given to the membership at least one (1) 13 week in advance of the meeting. 14

The requirements regarding method of election and notices may be modified for Local Unions in Canada by the International Executive Board.

19 20 No member shall at the same time be a candidate for or hold more than one of the following offices: President, Vice President, Recording Secretary, Financial Secretary, Treasurer, Guide, Guard, and Trustee.

21 A Local Union which has a membership of one 22 23 hundred (100) or less may adopt a by-law provision providing only for the offices of President, Vice President, 24 25 Recording Secretary, Financial Secretary and Treasurer, and the by-laws shall provide how the duties of the offices 26 of Guide, Guard and Trustee are to be allocated among 27 these five (5) offices. In the alternative, a Local Union 28 which has a membership of one hundred (100) or less may 29 adopt a by-law provision which, in addition to providing 30 31 for the five (5) offices mentioned above, combines the 32 office of Guide and/or Guard with the office of Trustee.

Section 9. No member shall be eligible for election as a Local Union Officer or Grievance Committee Member unless:

4 (a) The member shall have been in continuous 5 good standing for a period of twenty-four (24) months 6 immediately preceding the month in which the election is 7 held, or if the member's Local Union has been in existence 8 for a lesser period prior to the election, the member must 9 have been in continuous good standing from the time that 10 the member joined such Local Union; and

(b) The member is employed in an enterprise, public or private, or other place within the jurisdiction of the Local Union.

Section 10. In order to be eligible for election as a Local Union Officer or Grievance Committee Member in any regular election or election to fill a vacancy, a member shall have attended at least one-third (1/3) of the regular meetings held by the member's Local Union during the twenty-four (24) month period immediately preceding the month in which the election is to be held.

Meetings which a member was prevented from attending because of such member's Union activities, working hours, service in the armed forces of the United States or Canada, sickness which confines, childbirth (if the meeting occurs within twelve (12) weeks of the date of birth), death in the immediate family, or jury duty, shall not be counted as meetings held in determining such member's eligibility under this Section 10; provided, that the member shall have the burden of proving inability to attend for one of the prescribed reasons, in accordance

with procedures to be specified in the Local Union Elections Manual

In the event none of the members nominated for a particular office is eligible, then both Section 9(a) and this Section 10 will be considered waived automatically for that office and the election for that office will be

7 conducted among those members nominated who meet 8 the requirements of Section 9(b) of this Article.

Section 11. A Workers' Compensation Committee and a Safety and Health Committee, under the direction of the International Union or its designated representative, shall be established in each Local Union.

Section 12. A Civil Rights Committee (which may also be known as a Human Rights Committee), under the direction of the International Union or its designated representative, shall be established in each Local Union to implement our Union's commitment to the protection and extension of civil and human rights and liberties.

With respect to an Amalgamated Local Union, the
Local Union President shall for each Unit either appoint
a Unit Representative to the Committee or cooperate with
the Unit Chair to establish a Unit-based Committee.

Section 13. To further our commitment to encourage activism, leadership development and greater understanding of gender issues in our Local Unions with female membership, a Women's Committee, under the direction of the International Union or its designated representative, shall be established by such Local Unions.

Section 14. An Organizing Committee under the

ARTICLE VIII

Duties of Local Union Officers

Section 1. Duties of President. The President shall 12 preside at all meetings of the Local Union and preserve 13 14 order, and shall decide all questions of order, subject to an appeal to the Local Union. The President shall have 15 the right to vote at all elections of officers, and, when the 16 members are equally divided on other questions, shall 17 have the deciding vote. The President shall call special 18 meetings by request of ten (10) members in good standing 19 of the Local Union, and shall enforce the provisions of this 20 Constitution. The President shall appoint all committees 21 not otherwise provided for and be ex-officio member of all 22 committees. The President shall perform such other duties 23 as the Local Union may assign. 24 25 In the event that a vacancy occurs in the office of

Vice President, Recording Secretary, Financial Secretary,

- 1 Treasurer, Guide, Guard or Trustee or in the position
- 2 of Grievance Committee Member at any time during
- 3 the term of office, the remaining Local Union Officers
- 4 shall, by majority vote, select a successor to serve for the

- Section 2. Duties of Vice President. The Vice
 President shall assist the President in the discharge of
 the President's duties and during the President's absence
 shall perform the duties of the President. In the event
 that a vacancy occurs in the office of President, the Vice
 President shall act as President for the unexpired term.
- 12 Section 3. Duties of Recording Secretary. The Recording Secretary shall record the proceedings of 13 14 the Local Union in a book kept for that purpose, read 15 all papers and perform such other duties required under this Constitution and as the Local Union may assign. The 16 Recording Secretary shall also have custody of the Local 17 Union Seal, and shall be responsible for any misuse of 18 19 same.
- 20 Section 4. Duties of Financial Secretary. The Financial Secretary shall receive all money due the Local 21 Union and pay the same to the Treasurer, from whom the 22 Financial Secretary shall take a receipt. The Financial 23 Secretary shall also keep accurately the accounts of the 24 Local Union with its members, and shall at all times 25 have the books open for examination by the Auditing 26 Committee, and perform such other duties required under 27 the Constitution and as the Local Union may assign. The 28

Financial Secretary shall make out the various reports required by the International Secretary-Treasurer and

1 forward such reports to the International Secretary-Treasurer in accordance with instructions. 2

Should it be proved that a Local Union Financial 3 Secretary has failed to report monthly the 4 5 membership of the Local Union as provided for in the 6 report to the International Secretary-Treasurer and transmit the full amount of initiation fees and dues, the 7 Financial Secretary shall be suspended from all privileges 8 and benefits until the deficiency is made good, and shall be 9 liable to the International Union for the full amount unpaid. 10 11

The Financial Secretary shall keep a record of all transfer request forms issued and received.

12

The Financial Secretary's accounts shall be subject at 13 14 all times to audit by the International Secretary-Treasurer.

15 Section 5 Duties of Treasurer The Treasurer shall 16 receive from the Financial Secretary all money collected by the Financial Secretary and shall deposit all money 17 belonging to the Local Union in a bank designated by 18 it. All initiation fees and dues shall be deposited in a 19 20 separate bank account to be designated as a trust fund for the International Union. The Treasurer shall cause to be 21 issued to the Financial Secretary a receipt for all money 22 turned over to the Treasurer or deposited to the Treasurer's 23 credit in the regular bank account. The Treasurer shall 24 issue a separate receipt for the amount of money turned 25 over at any time or for such deposit made, and shall sign all 26 checks and have them countersigned by the President and 27 the Financial Secretary. At the option of the Local Union, 28 a Vice President, who is designated in advance, can serve 29 30 as an alternative signatory. The Treasurer shall keep regular and correct accounts

of all money received and paid, and report at each meeting

- the balance of cash shown by the last report, the amount
- received since, the total checks issued and authorized, 2
- and the balance remaining. The Treasurer's accounts 3
- shall be open for examination by the Auditing Committee 4
- at any time when called upon. The Treasurer's books 5
- 6 shall be subject at all times to audit by the International
- Secretary-Treasurer of the United Steelworkers. The 7
- Treasurer shall perform such other duties required under 8
- the Constitution and as the Local Union may assign. 9
- 10 Section 6. It shall be the duty of the President,
- Financial Secretary and Treasurer to insure that the 11 funds and property of the Local Union are preserved, 12
- managed, invested and expended in accordance with the 13
- International Constitution and policies and Local Union 14
- By-Laws.
- 15
- Section 7. Duties of Guide. It shall be the duty of the 16 Guide to see that all present are entitled to remain. 17
- Section 8. Duties of Guards. It shall be the duty of 18
- the Guards to take charge of the door and see that no one 19
- enters who is not entitled to do so. 20
- 21 Section 9. Duties of Trustees. It shall be the duty of
- 22 the Trustees to have charge of the hall and all property
- of the Local Union, subject to the direction of the Local 23
- Union, and perform such other duties as the Local Union 24
- may require. 25

ARTICLE IX

Suspension or Revocation of Local Union Charters

Section 1. In the event the International President 1 2 shall have reason to believe that any Local Union is failing to comply with any provision of the Constitution, 3 or that action may be required for one of the purposes 4 specified in the following Section, the International 5 President may, unilaterally or at the request of officers or 6 members of the Local Union, institute proceedings, with 7 due notice of the basis therefor and of a hearing before 8 any member or members of the International Executive Board or representative or representatives designated by 10 the International President. The Local Union shall 11 be afforded a full and fair hearing. Upon the basis 12 of the hearing the International Executive Board 13 authorized to render a decision, dismissing the 14 proceedings, suspending or revoking the charter of 15 any such Local Union, or directing such other action 16 17 as may be necessary to secure compliance with the Constitution. The International Executive Board may act 18 at a meeting or by means of a mail or telegraphic poll. 19

Section 2. Included in the other action which the 20 International Executive Board (or such committee of 21 its members as it may select to perform all or part of 22 its functions) may direct are the removal, by it or by 23 the Administrator provided for in this Article, of all 24 or any of the Local Union Officers, grievance or other 25 26 committee members or stewards, and appointments of an Administrator over the affairs and property of any 27 such Local Union for any of the following purposes: (a) 28

1 correcting corruption or financial malpractice, (b) assuring the performance of collective bargaining agreements or 2 other duties of a bargaining representative, (c) restoring 3 democratic procedures, or (d) otherwise carrying out the 4 legitimate objects of the International Union or such Local 5 6 Union

If the decision of the International Executive Board 7 on the report and recommendations of the hearing 8 commission is rendered by means of a poll when it is 9 not in session, the matter shall be considered again at 10 11 the next meeting of the International Executive Board following request for such consideration by an aggrieved 12 party provided such request is filed with the International 13 Secretary-Treasurer within thirty (30) days after the 14 decision is made known to the Local Union. 15

16 Section 3. Notwithstanding anything to the contrary herein, in case of emergency, where in the opinion of the 17 International President the best interests of the International 18 Union or Local Union require, the International President 19 20 is empowered to suspend officers of, and establish an administratorship over, the affairs and property of a Local 21 Union prior to notice and hearing. In such cases notice 22 23 shall be given and a hearing as specified above shall be conducted within sixty (60) days following the emergency 24 action. 25

Section 4. The Local Union shall be notified of 26 the time and place of any meeting of the International 27 Executive Board at which the Local Union's status will 28 29 be considered. The parties shall have the right to appear 30 before the International Executive Board at such meeting. 31

Section 5 The decision of the International Executive 4

5 Board may be appealed to the next International

Convention, provided that notice of the appeal is filed 6 with the International Secretary-Treasurer within thirty 7

(30) days after the decision is made known to the Local 8

Union. Pending the appeal the decision of the International 9

Executive Board shall remain in full force and effect. 10

The International Convention may affirm, reverse or 11

modify the decision of the International Executive Board. 12

Section 6. In the event that an Administrator is 13 14 appointed for a Local Union, the Administrator shall take 15 full charge and conduct all the affairs of the Local Union until the International Executive Board determines that 16 the Local Union is capable of conducting its own affairs 17 in conformance with the Constitution and policies of the 18 19 International Union and By-Laws of the Local Union. The Administrator shall have the right to demand and receive 20 in the name of the International Union, and the Local 21 Union Officers shall have the obligation to turn over, the 22 charter and all books, records, monies, assets and property 23 of the Local Union, to be held in trust for the Local Union 24 25 and to be used and expended only in the proper conduct of its affairs. The Administrator shall have the right to 26 replace officers, grievance or other committee members 27 or stewards removed by the International Executive Board 28 or the Administrator, by appointing temporary officers, 29 30 grievance or other committee members or stewards. 31

All officers, grievance or other committee members or

stewards, incumbent or temporary, shall function under the
 supervision, direction and control of the Administrator. The
 International President shall have the right, with or without
 cause, to remove or replace the Administrator at any time.

4 5 It shall be the policy of the International Executive 6 Board to terminate an administratorship as soon as it deems practicable under all the circumstances. When 7 the International Executive Board determines to restore 8 the autonomy of an administered Local Union, the 9 Administrator shall (unless the International Executive 10 11 Board or its delegee determines otherwise), prior to such restoration, be responsible for conducting an election, 12 in accordance with the applicable provisions of the 13 Constitution and policies of the International Union 14 and By-Laws of the Local Union, to fill vacant offices 15 16 and other elective positions vacated on account of 17 removal or departure of the former elected incumbents.

Section 7. In the event an enterprise, public or private, which constitutes the sole jurisdiction of a Local Union, is abandoned, the International Secretary-Treasurer with the consent of the International Executive Board, may revoke the charter of said Local Union.

Section 8. In the event of a suspension of a Local Union, the members thereof and the Local Union shall not be deemed to be in good standing during the period of suspension.

Section 9. In the event that a Local Union's charter is revoked, or the Local Union disbands, the charter and all books, records, monies, assets, and property shall be delivered and turned over immediately to the International

- Union on demand by the International Secretary-Treasurer
- 2 or the International Secretary-Treasurer's designee.
- 3 Section 10. After a charter of a Local Union has been
- 4 revoked, the International Executive Board may charter a
- 5 new Local Union having the same jurisdiction as the Local
- 6 Union whose charter was revoked. The members of the
- 7 Local Union whose charter was revoked may be readmitted
- 8 only by action of the International Executive Board.

1 Section 2. The territorial boundaries of the Districts 2 have been fixed by vote of the International Executive Board. The International Executive Board, by a two-3 thirds (2/3) vote, shall have the authority, as conditions 4 may require, to change the boundaries of the Districts 5 or to consolidate two or more Districts. In the event of 6 such consolidation, the Executive Board shall have the 7 authority, by a two-thirds (2/3) vote, to determine which 8 District Director among the consolidated Districts shall be 9 the District Director of the single District. 10

Section 3. In the event the International Executive Board between International Conventions establishes a new District, it shall proceed to arrange for an election of a District Director for such new District by a referendum vote of the members of the International Union in such new District in the same manner as a regular election.

ARTICLE XI

Membership

- 17 Section 1. No applicant for membership shall be 18 regarded as being a member in good standing until the full 19 amount of the initiation fee has been paid.
- Section 2. A member shall pay dues promptly commencing with the month during which the member shall have been admitted, and shall continue to pay all dues, assessments and fines or other obligations promptly when due in order to be and remain in good standing.
- 25 Section 3. A member who has not lost good standing

under other provisions of this Constitution shall be in good standing if not more than three (3) months in arrears in any constitutional obligations, except in respect to assessments on which the member shall be not more than one (1) month in arrears

6 Section 4. Members who lose good standing shall
7 stand automatically expelled and devoid of all membership
8 rights, and shall not be reinstated in good standing except
9 upon such terms as the Local Union and the International
10 Executive Board may decide.

11 Section 5. Any member who retains employee status in a bargaining unit represented by the International 12 Union but who because of layoff has not, for twenty-13 four (24) continuous months, performed at least five (5) 14 15 days' work in any month in such bargaining unit shall be deemed not in good standing (but not expelled) and 16 devoid of all membership rights until such time as the 17 member is recalled or obtains employment in a bargaining 18 19 unit represented by the International Union and resumes payment of current dues, at which time the member shall 20 automatically be restored to good standing. No Local 21 Union Officer or Grievance Committee Member shall lose 22 good standing under this Section for the remainder of the 23 term in office. 24

term in office.

The International Secretary-Treasurer shall, upon request and under procedures established by the International Executive Board, issue honorary withdrawal cards to members in good standing whose membership is involuntarily terminated.

Section 6. A member not in good standing shall not be permitted to vote, nominate for office, hold office, or be a candidate for office

Section 7. A member whose membership is terminated shall have no right or interest in any property of the Local Union or of the International Union, including any dues, assessments or other financial obligations paid by such member in advance of the effective date of such termination.

Section 8. To further organization in Canada and 10 elsewhere, the International Executive Board, during 11 organizational campaigns and until collective bargaining 12 contracts are negotiated, may grant dispensations 13 from payment of initiation fees, dues or other financial 14 15 obligations or may reduce the amount of dues, initiation fees or other financial obligations payable by members 16 and prospective members and may determine the 17 apportionment thereof between the International Union 18 19 and Local Unions when, in its judgment, such dispensation or reduction will promote the growth or interests of the 20 International Union, and such members, meeting all 21 other eligibility requirements of the Constitution, shall be 22 regarded as being members in good standing during such 23 organizational period, for all purposes, any provision of 24 this Constitution relating to initiation fees, dues and other 25 financial obligations to the contrary notwithstanding. 26

ARTICLE XII

Discipline

Section 1. Any member may be penalized for 1 2 committing any one or more of the following offenses: (a) violation of any of the provisions of this Constitution, 3 any collective bargaining agreement, or by-laws or rules 4 of the Local Union; (b) obtaining membership through 5 fraudulent means or by misrepresentation; (c) instituting, 6 or urging, or advocating that a member of any Local Union 7 institute action outside the Union against the International 8 Union, Local Union or any of their officers without first exhausting all remedies through the forms of appeal of 10 the International Union; (d) advocating or attempting to 11 12 bring about the withdrawal from the International Union 13 of any Local Union or any member or group of members; (e) publishing or circulating among the membership false 14 reports or misrepresentations¹; (f) working in the interest 15 of or accepting membership in any organization dual to the 16 17 International Union; (g) slandering or willfully wronging a member of the International Union¹; (h) using abusive 18 19 language or disturbing the peace or harmony of any meeting in or around any office or meeting place of the 20 International Union; (i) fraudulently receiving any money 21 due the organization or misappropriating the monies of the 22 organization; (j) using the name of the Local Union or the 23 International Union for soliciting funds, advertising, etc., 24 of any kind without the consent of the appropriate body or 25 officer of the International Union; (k) furnishing a complete 26

1 or partial list of the membership of the International

2 Union or of any Local Union to any person or persons

other than those whose official position entitles them 3

to have such a list; (1) deliberately interfering with any 4

5 official of the International Union in the discharge of that

6 official's duties; (m) deliberately engaging in conduct

in violation of the responsibility of members toward 7 the organization as an institution; and (n) deliberately 8

interfering with the performance of the organization's

9 legal or contractual obligations. 10

11 Section 2 It is an offense under this Constitution to harass a member at a union or workplace-related location 12 or activity on the basis of race, creed, color, sex, sexual 13 orientation, gender identity, age, disability, nationality, or 14 15 other legally protected status.

16 Section 3. Any member convicted of any one or more of the above offenses may be denied the right 17 to be a candidate for or hold office or position in the 18 19 Union, declared a member not in good standing, fined or otherwise appropriately disciplined. 20

21 Section 4. If any officer of the Local Union, or 22 delegate to an International Convention, is convicted of any one or more of the above-named offenses, such person 23 may be penalized as described above, and removed from 24 office or position. 25

ARTICLE XIII

Trials of Members and Local Union Officers²

- Section 1. Any charges against a member or a Local
- 2 Union officer must be first submitted in writing to the
- 3 Local Union of which the individual charged is a member
- 4 or an officer. The charges shall be sufficiently specific so
- 5 as to enable the accused to prepare a defense.
- 6 Section 2. Upon the submission of the charges, the
- 7 Recording Secretary of the Local Union shall send a copy
- 8 thereof by certified mail or registered mail to the accused
- 9 member at that member's last known address. The charges
- must be presented to the membership at the next regular
- 11 meeting of the Local Union for designation of a Trial
- 12 Committee.
- Section 3. The Local Union shall designate a Trial
- 14 Committee in a manner to be specified by the Local
- 15 Union By-Laws. Neither the accuser nor the accused
- shall be eligible for membership on the Trial Committee.
- 17 Immediately after the Local Union meeting referred
- 18 to in Section 2, the Recording Secretary shall provide
- 19 the accused and the accuser at their last known home
- 20 addresses with written notification of the time and place
- 21 when the hearing will be held before the Trial Committee.
- 22 The hearing shall take place no sooner than two weeks and

no later than four weeks after the mailing of said notice.

Section 4. The Trial Committee shall report its 2 findings to a meeting of the Local Union. The membership 3 4 shall be given adequate notice of the fact that the findings 5 will be presented at the particular meeting. The Local Union shall take such action on the report of the Trial 6 Committee as it may deem proper and, in the event the 7 accused is found guilty of the charges preferred, shall 8 impose such penalties as in its judgment it may deem 9 10 fitting and proper.

Section 5. In the event that the accused fails to appear 12 at the hearing at the time and place provided in the notice and presents no reasonable excuse for absence, the hearing 13 14 shall proceed with the same force and effect as if the 15 accused were present.

11

Section 6. The accused or the accuser may appeal 16 to the International Executive Board and thereafter to 17 18 the next regular International Convention provided that such person files notice of appeal with the International 19 Secretary-Treasurer within thirty (30) days after notice 20 of the decision of the Local Union or the International 21 Executive Board from which the appeal is taken. For 22 appeals to the International Executive Board, the 23 International Executive Board shall adopt procedures 24 which insure that all parties are afforded the opportunity 25 to present all arguments and facts whether or not presented 26 at the earlier stages in the proceedings and that decisions 27 28 on such appeals are based upon the evidence presented in 29 the appeal. The International Executive Board shall not, in making its decision, be limited to the arguments or 30

testimony presented at the earlier stages in the proceedingsand shall be permitted to cure by its appeal proceedings

3 procedural defects which may have occurred at earlier

4 stages in the proceedings. The decisions of the Local

5 Union and of the International Executive Board shall be

6 given full force and effect unless a stay thereof is obtained

7 from the International Executive Board. The Executive

8 Board, in its discretion, may in reversing a decision order a

9 Local Union to compensate an individual member for any

10 loss incurred as a result of said decision.

11 Section 7. At any time during the processing of charges alleging a serious violation by a Local Union 12 official or member of Section 2 of Article XII, the 13 International President may, upon written request (sent by 14 15 certified mail, overnight courier or other means providing 16 proof of receipt), and where supported by preliminary investigation conducted on behalf of the International 17 President, summarily remove such Local Union official 18 from office or suspend such member from good standing 19 20 during all or a portion of the time necessary to process the charge. 21

Section 8. It shall be the duty of a member to exhaust all said member's internal remedies and appeals provided under the Constitution and policies of the International Union and the Local Union By-Laws.

Section 9. Notwithstanding any provisions of this Article XIII to the contrary, any member of the International Executive Board who believes that a violation of the International Constitution or the International Union

- 1 not being properly pursued under this Article XIII may
- 2 file a charge alleging such violation. The International
- 3 Executive Board may (1) cause a hearing on such charge
- 4 to be conducted and issue a decision thereon, or (2) refer
- 5 such charge to the Local Union involved for appropriate
- 6 handling under Article XIII.

ARTICLE XIV

Finances

- 7 Section 1. Except for newly organized Units, where
- 8 initiation fees are waived pursuant to Section 2, the
- 9 initiation fees shall be Ten Dollars (\$10.00).
- Section 2. The International Executive Board may
- 11 grant dispensations from payment of initiation fees when
- 12 in its judgment such dispensation will promote the growth
- 13 or interests of the International Union.
- Section 3. Monthly dues for a member shall be an
- 15 amount equal to 1.3% of said member's total earnings
- 16 during the month provided that monthly dues shall not be
- 17 less than \$5.00 and provided further that monthly dues

- 19 hourly earnings. For lump sum payments, dues shall

- Section 4. Notwithstanding any other Section of
- 24 this Article, Local Unions whose dues at the time of

 by adding such differential to the amount required by the
 applicable provisions of this Article.

5 In addition, a Local Union which has removed the 6 cap of 2.5 (or other multiple) times the member's average hourly earnings referred to in Section 3 of this Article 7 may, with the approval of the International Secretary-8 Treasurer, establish a supplemental local strike and 9 defense fund to be financed by an increase in dues adopted 10 11 by the Local Union by secret vote, which increase shall not exceed \$3.50 per member per month. Distributions 12 from the local supplemental strike and defense fund shall 13 be in accordance with the rules of the International Strike 14 and Defense Fund and such additional rules as may be 15 16 established by the International Secretary-Treasurer.

Section 5. The full amount of all dues and initiation 17 fees and assessments collected by each Local Union shall 18 be deposited by the appropriate officers of the Local 19 Union in a bank account designated as a trust fund held for 20 the International Union. The officers of each Local Union 21 22 shall forward to the International Secretary-Treasurer within fifteen (15) days after the close of any month, the 23 full amount of the dues and initiation fees and assessments 24 collected by such Local Union. 25

Section 6. The International Secretary-Treasurer shall, upon receipt of any remittance of initiation fees referred to in Section 1 of this Article, determine and remit to the Local Union Financial Secretary a per capita refund which shall be one-half (1/2) of the amount received, the balance to be retained by the International Secretary-

- 3 Section 7. The International Secretary-Treasurer
- 4 shall, upon receipt of any remittance of dues referred to

 Financial Secretary as a per capita refund.
- 27 Section 8. When any Local Union fails to report 28 and remit to the International Secretary-Treasurer the

- 3 Treasurer shall notify the Local Union President and the
- 4 Recording Secretary of the Local Union of the fact, and
- 5 failing to receive a satisfactory response within ten (10)

- 16 which the member has not become entitled to five days'
- pay or its equivalent in wages and benefits in lieu of wages.

- 22 in Section 10 of this Article, and Article XI, Section 8,

Section 14 The International Executive Board on 11 12 request of a Local Union shall have the power to make special arrangements with respect to the dues schedules 13 established in this Article where unusual circumstances 14 15 justify such arrangements. The International Executive Board shall establish a procedure under which any 16 individual, who is required as a condition of employment 17 to pay dues to the International Union pursuant to a union 18 19 security arrangement, who has elected to be a financial core member and thereby has no rights of membership, 20 and who objects to supporting partisan political or 21 ideological expenditures by the International Union 22 which are not necessarily or reasonably incurred for the 23 purpose of performing the duties of an exclusive collective 24 25 bargaining representative shall have the right upon perfecting a notice of objection to obtain a reduction of a 26 portion of such individual's dues obligation commensurate 27 with such expenditures unrelated to Collective Bargaining 28 29 as required by law.

23 (d) In addition, a Local Union may, by secret vote and with the approval of the International Secretary-Treasurer, 24 further increase members' monthly dues by a percentage 25 no higher than 0.1% of its members' total earnings during 26 the month, provided that monthly dues shall not be less 27 28 than \$5.00 nor more than an appropriate adjusted cap 29 as determined by the International Secretary-Treasurer. This additional dues of up to 0.1% shall be distributed in 30

Such associate organization(s) shall be affiliated with the 7 United Steelworkers. Those eligible for membership in 8 a USW associate organization shall include former and 9 potential members. Those eligible for regular membership 10 11 in USW pursuant to Article III shall not be eligible for membership in a USW associate organization. Persons 12 who meet the conditions for membership in a USW 13 associate organization shall not be entitled to vote or 14 run for an office or position in an election governed by 15 16 Articles IV, V, VI or VII of this Constitution. However, such persons shall be entitled to vote and hold office and 17 otherwise participate fully in the associate organization to 18 the extent and under rules provided by the International 19 Executive Board. 20

ARTICLE XIX

Steelworkers Organization of Active Retirees (SOAR)

21 Section 1. The Steelworkers Organization of Active

22 Retirees (SOAR), an affiliate organization of the United

23 Steelworkers, is governed by By-Laws which are subject

- to amendment by the International Executive Board of
- the United Steelworkers 2
- Section 2. All members in good standing of the 3
- 4 International Union who retire shall, at the time of
- 5 retirement, be granted membership in SOAR. All members
- of SOAR shall be eligible for SOAR chapter membership 6

9 Section 3. Local Unions and SOAR Chapters

- (a) Each Local Union having more than twenty-five 10 11

ARTICLE XXII

Severability

- In the event any clause or provision of this Constitution is determined to be unlawful or unenforceable, in whole or in part, such clause or provision shall, in the jurisdiction in which and to the extent that it is unlawful or unenforceable,

- provisions of this Constitution and all other provisions of
- 18 this Constitution shall remain in full force and effect.

ARTICLE XXIII

Leadership of Rubber/Plastics Industry Conference, National Oil Bargaining Sector and National Paper Bargaining Sector

In recognition of the commitment made in the merger between the former USWA Union and the former URW Union, the person assigned to be head of the Rubber/Plastics Industry Conference (R/PIC), by the International President shall come out of the R/PIC and be knowledgeable about the rubber and plastic industries and its bargaining.

In recognition of the commitment made in the merger between the former USWA Union and the former PACE Union, the person assigned as Chairperson of the National Oil Bargaining Sector by the International President to be responsible for the administration of the National Oil Industry Bargaining Program, shall come out of, and be knowledgeable about the oil industry and its bargaining.

In recognition of the commitment made in the merger between the former USWA Union and the former PACE Union, the person assigned by the International President to be responsible for bargaining in the paper industry, shall come out of, and be knowledgeable about the paper industry and its bargaining.

MANUAL

Opening of Meeting

The hour of the meeting having arrived, the President shall take the chair and give one rap with the gavel, upon which all officers and members shall be seated. If no regular Guards are present, the President shall appoint one of the members to see that none but members of the Union are admitted.

President: The time for opening this meeting having arrived, I declare this meeting duly convened and qualified to consider measures tending to conserve the best interest of this Local Union, and the United Steelworkers.

ORDER OF BUSINESS FOR CONDUCTING LOCAL UNION MEETINGS

- 1. Call meeting to order.
- 2. Roll call of officers by Recording Secretary.
- 3. **Reading of the minutes of the previous meeting.**After the minutes have been read by the Recording

Secretary a motion must be made and seconded that the minutes be "approved" (or adopted) as read. Such a motion means that in the opinion of the members, the Secretary has recorded the minutes of the previous meeting correctly. Should the reading reveal any errors or omissions, a member may move to correct the minutes. If this motion is carried, another motion should follow that the minutes "as corrected" now be approved.

IT IS VERY IMPORTANT THAT BRIEF, COMPREHENSIVE MINUTES OF EACH MEETING BE KEPT BY THE RECORDING SECRETARY. THESE MINUTES ARE THE OFFICIAL RECORD OF THE BUSINESS TRANSACTED BY THE LOCAL UNION MEETING. A REGULAR BOOK IS PROVIDED BY THE INTERNATIONAL UNION FOR THIS PURPOSE AND SHOULD ALWAYS BE KEPT UP TO DATE.

4. Reading of Communications.

RECORDING SECRETARY: The Recording Secretary reads the letters which require attention. Those which do not require much discussion may be dealt with immediately; others may be laid over to "New Business" or referred to a standing committee. If no action is required or desired, the communications may be read and, upon a motion, filed. The Recording Secretary keeps the files of the Local Union

5. Report of Officers.

FINANCIAL SECRETARY: The Financial Secretary should make a detailed financial report at least once each month at the Local Union meeting covering the receipts and expenditures of all funds of the Local Union. If the expenses of the Local Union exceed its current income or impair its reserves, the Financial Secretary is obligated to call this fact to

the attention of the membership.

TREASURER: The Treasurer is the custodian of the Local Union funds. The Treasurer should report to each meeting the money received from all sources, such as rebates from the International Office and other monies turned over to the Treasurer for deposit by the Financial Secretary. The Treasurer should be certain that the amount reported by the Financial Secretary to the Local Union as having been turned over agrees with what the Treasurer actually received and that the Recording Secretary records the amount in the minutes

TRUSTEES: The Trustees are the custodians of the hall and all property of the Local Union subject to the direction of the Local Union. They shall audit the books and financial records of the Local Union every three (3) months and give a report of such audit at the next regular Local Union meeting.

- 6. Report of Organizer or International Representative.
- 7. Initiation of New Members.
- Report of Special Committees.
 Such as: Celebrations, picnics, relief, citizenship, etc.
- 9. Reports of Standing (or Permanent) Committees.
 - a. Grievance Committee.
 - b. Report of delegates to Federation Council.

10. Unfinished Business.

These matters are those remaining over from previous meetings. They are usually recorded in the minutes of the previous meeting. The Recording Secretary should inform the President of any unfinished business so it may be included in the order of business in this section.

11 New Business.

These are matters which have been laid aside earlier in the meeting or which have come up since the last meeting.

12. Good and Welfare.

All miscellaneous matters for the good of the Union which should be brought to the attention of the meeting should come to the floor at this time. These matters usually do not require any action by the meeting. They are simply matters of information and education.

13. Adjournment.

PRESIDENT: The business of this meeting having been duly transacted, I declare it adjourned until our next regular session, unless you are especially called together, when I hope to see all members present. NOTE: All money paid out by the Local Union from its treasury must be approved by the members at a Local Union meeting. Bills charged to the Local Union should be submitted to the Recording Secretary, who in turn submits them to the Local Union meeting for approval. If the Local Union agrees that the bills should be paid a motion should

be made, seconded and passed authorizing the Treasurer to draw up a check and pay the bill. All Local Union checks must be signed by the Treasurer and countersigned by the Financial Secretary and the President

Under no circumstances is it legal for officers or members to pay bills without authorization by a Local Union meeting, nor shall the members authorize payment of any bill or incur any obligation for which funds are unavailable, nor shall the members authorize the payment of or incur a debt for any activity not in accordance with the Constitution and policies of the International Union and the By Laws for Local Unions. Under no circumstances shall any of the cash dues or fees collected be spent before it is sent to the International Secretary-Treasurer

It is of prime importance that the Trustees shall audit the books and financial records of the Local Union every three (3) months and give a report of such audit at the next regular Local Union meeting. The Trustees should give special attention when checking disbursements recorded by the Financial Secretary and Treasurer that proper authorization for such payments have been entered by the Recording Secretary in the Minutes of the Local Union. (Constitution: Article VII, Section 4; Article VIII, Section 6. By Laws for Local Unions: Article V.)

INITIATION OF NEW MEMBERS

President - Raise your right hand.

"Recognizing that the United Steelworkers is a strong labor organization dedicated to the advancement of my interests and the interests of all workers and that the strength of the Union depends on the commitment which its members make to it and to each other, I do sincerely promise, of my own free will, to abide by the laws of this Union; to bear true allegiance to, and keep inviolate the principles of the United Steelworkers; never to discriminate against a fellow worker on the basis of race, creed, color, sex, sexual orientation, gender identity, age, disability, nationality, or other legally protected status; to defend freedom of thought, whether expressed by tongue or pen, to defend on all occasions and to the extent of my ability the members of our organization, and never to reveal to any employers or their agent a member's name without proper authorization. I will cease work when authorized and approved by the organization to do so.

That I will look upon my fellow members of this Union as my brothers and sisters and will never knowingly wrong a member or see a member wronged if I can prevent it. That I will assist all members of our organization to obtain the highest wages possible for their work; that I will not accept a member's job who is idle for advancing the interests of the Union or seeking better remuneration for the member's labor; and, as the workers of the entire country are competitors in the labor world, I promise to provide my solidarity and support whenever I am called upon by the organization to do so. And I further promise to

help and assist all members in adversity, and encourage all workers to organize and join our Union in order to enjoy more fully the fruits of their labor.

To all this I pledge my honor and I further pledge that at every opportunity I shall 'Say A Good Word About My Union."

INSTALLATION OF OFFICERS

I,, do hereby sincerely pledge my honor to perform the duties of my office as prescribed by the Laws of the organization, and to bear true allegiance to the United Steelworkers. I will deliver to my successor in office all books and other property of this Union that may be in my possession at the close of my official term. All of this I solemnly promise, with full knowledge that to violate this pledge is to stamp me as a person devoid of principle and destitute of honor.

With bowed heads and saddened hearts we have followed his (her) remains to this place in order that we may be able to show this last tribute of respect to the memory of one whose virtues we appreciate and whose faults, if he (she) had any, we are eager to forget. We have known him (her), he (she) was one of us, and our hearts grieve at his (her) departure, as the heart of man always grieves at the loss of some cherished object of

affection that can never be replaced, yet our grief is not inconsolable. Of what consequence is a few years to the age of man when compared with God's infinity? When we think of the many years that have rolled into eternity since time began and the countless ages yet to come ere time shall be no more, we realize that the short period allotted to man on this earth is but the first self conscious gleam of man's eternal soul. We are not as men without hope, for the Psalmist has said, "Man that is born of woman is full of trouble and sorrow. He cometh forth like a flower and is cut down. Our years of labor are brought to an end, our dust shall return to dust as it was, and our spirit to the God who gave it." Earth to earth, ashes to ashes, dust to dust.

Though the seasons may change, and the years pass away, the remembrance of our Brother (Sister) shall never fade until we, too, have been gathered to the place that has been prepared for us.

family of our deceased Brother (Sister). Comfort them in their affliction. Guide us all in the paths of righteousness while we live, and when we are done with this life receive us into that home which Thou hast prepared for all Thy children, eternal in the Heavens. Amen.
